Our History: **Building with Local Bricks**

house on Stewart Line was built cica 1856 using bricks that were kilned at a clay deposit not far east of us on Lot 22. Concession 12. Cavan. The area was settled in the 1820s and '30s, before any roads were built along the surveyed road allowance. At that time the properties were connected only by a trail through the blazed forest.

When the road was constructed, settlers kept to the

Our red clay brick farm- higher ground to avoid water courses, swales and dense cedar bush. It was at one of these swales that an exposed clay outrop was discovered. The owner realized that this type of clay could be kilned into bricks. In 1854, he made enough bricks to build his own house which was on Lot 22.

By that year, the 12th Line of Cavan had been constructed from what is now County Road 10 (the former Bobcaygeon Colonization Road) east to meet the road to Peterborough. Now it was possible to transport bricks by cart or wagon to other properties. In 1856 our Georgian house was constructed, using these locally made bricks. A brick bake oven and other outbuildings were added later.

Other buildings in the area built using the same brick-yard include the Presbyterian Church manse, Fairmount Methodist Church, SS No. BRICKS... Continued on Page 9

Strikingly familiar.... The Cuckoo's Calling by Robert Galbraith (aka J.K. Rowling)

J.K. Rowling wanted to keep her little cuckoo a secret. There is no way of being totally unbiased once you know this book is hers and I only wish I had had the luck to read it when it first came out and before the balloon went up. I think the title, though entirely apt for the story, indicates also a slyly-hidden egg laid in the nest of book critics. There were clues that this book was written neither by an ex-commando (as the jacket cover says) nor even by a man, but of course, after the fact, that is

easy for me to say. Save for being a downand-out PI, Cormoran Strike is rather unusual. He is ex-military police; one-legged due to a bomb blast in Afghanistan; very large and hairy-Hagridian one might say-and the illegitimate son of a famous rock star. His physical capabilities are not really tested too much in this first outing in what is touted to be a series, unless walking great distances through the streets of London counts. Whatever happened to the ubiquitous London cab?

Robin, Cormoran's new but temporary assistant, is a wannabe-sleuth and is endearingly breathless about her job and her assignments, although assignments may be too elegant a term. She is extremely self-motivated and eager to be part of what she sees as her dream job, responding enthusi-astically before her strange boss can even put together a request. Possibly, left to his

You can quite see why own devices, not much would get done at all, as he is still trying to recover from a break-up with his supermodel girlfriend and bivouacs in general squalor in his office. Robin, in fact, looks more and more like his guardian angel and she is definitely the more energetic of the two. Frankly, she turns out to be the better investigator as

> In quite a divergence from the usual popular police procedurals, this book is more cerebral and less action, the crime scenes are without excess violence and gratuitous gore; there is a visit to the mortuary but no detailed forensics done by overly-eager scientists examining body cavities; there are drugs and drink and all the vices usually present in such novels, but no depressing glimpse of the sordid aftermath of such. The Town of Millbrook contains Baxter Creek, a cold water stream. Our office can be contacted for fisheries management information if any in-water work is expected.

*Please contact the Department of Fisheries and Oceans/local Conservation Authority for any approvals that may be required and/or recommendations on any sediment/erosion control measures that may be required during construction.

Species at Risk

Species listed as endangered or threatened on the Species at Risk in Ontario (SARO) list are protected under the *Endangered Species Act*, 2007 (ESA). Section 9(1) of the ESA prohibits a person from killing, harming, harassing, capturing or taking a member of a species listed as endangered, threatened or extirpated on the SARO list. Section 10(1) of the ESA prohibits the damage or destruction of habitat of a species listed as endangered or threatened on the SARO list.

Since comprehensive mapping for most Species at Risk is not available and if the proposal involves site alterations, <u>a site assessment is recommended</u> to identify the presence of any Species at Risk and/or their habitat on the subject lands, as a decision should not be made in the absence of such information. The focus of the site assessment can include a review of the information about known occurrences along with other information sources such as species distributions and habitat requirements as well as field visits using MNR approved protocols during the appropriate seasons by a qualified professional.

It is the responsibility of a person(s) undertaking any proposed activity to ensure they are in compliance with all provincial and federal legislation including the ESA. Therefore a person(s) should ensure their proposed activities will not adversely affect a Species at Risk or its habitat protected under the ESA. If an impact to a Species at Risk or its habitat cannot be avoided, a person(s) may apply for an authorization under the ESA. However, if an authorization is not issued by MNR, the person(s) must comply with the ESA by modifying proposed activities to avoid impacts to Species at Risk and habitat protected under the ESA.

As of July 1, 2013, there are new regulatory provisions provided under the ESA. This regulatory provision allows eligible activities, such as work undertaken to repair, modify, demolish, replace or general maintenance of a structure or the removal of buildings and/or excavation of land that is considered to be species at risk habitat to proceed without a permit, provided the proponent register with the Ministry of Natural Resources and then follow the specific rules in regulation under the ESA. These rules include, but is not limited to, preparing a mitigation plan and implementing steps to minimize the adverse effects of the activity on the species identified.

If any species at risk are found during assessments or surveys, please contact the Species at Risk Biologist at the Peterborough District MNR office and provide the geographic location (UTM coordinates) as well as photographs of the species occurrences. If you have any questions regarding species at risk or the new regulations, contact the Species at Risk Biologist at the Peterborough District MNR office at 705-755-3104.

Significant Wildlife Habitat

The subject property may contain Significant Wildlife Habitat such as seasonal concentration areas for wildlife species (e.g. snake hibernaculum), rare vegetation communities (e.g. tallgrass prairie), specialized habitats of wildlife (e.g. turtle nesting and over-wintering areas), habitats of species of conservation concern (e.g. Special Concern species as identified on the Species at Risk in Ontario (SARO) list and animal movement corridors (e.g. amphibian movement corridors). The identification of Significant Wildlife Habitat is the responsibility of the respective planning authority.

We refer you to Section 9.3.2 of the Natural Heritage Reference Manual (NHRM) which provides guidance on determining criteria for when Significant Wildlife Habitat should be identified and evaluated. We also refer you to the Significant Wildlife Habitat Technical Guide which was prepared alongside the NHRM to assist planning authorities and other participants in the land use planning system. Public Lands Act

Except for federal canals and harbours, the beds of most lakes and streams are public land in Ontario. Please note that you may require a Work Permit under the Public Lands Act if you are proposing any work in water or near shore areas below the spring high water mark. Lakes and Rivers Improvement Act

Approval may be required under the Lakes and Rivers Improvement Act (LRIA) if you are planning to construct, alter, repair or decommission a dam. If you have any questions about the LRIA, please contact the Senior Lands and Waters Technical Specialist at 705-755-3305.

Other Approvals

It is the responsibility of the proponent to acquire all other information and necessary approvals from any other municipal, provincial or federal authority under other legislation. We recommend that you contact your local Conservation Authority, Department of Fisheries and Oceans, Trent Severn Waterway (Parks Canada), Ministry of the Environment, Ministry of Tourism, Culture and Sport, etc.

Thank you for sending a copy of the December 18, 2013 Notice of Study Commencement. The Notice indicates that the project will address capacity and reliability issues associated with the existing water storage system. The project is being planned as a schedule B activity in accordance with the Municipal Class Environmental Assessment (Class EA).

Class EA Process

The Eastern Regional Office in Kingston is a mandatory contact for all notices received as part of the Municipal Class Environmental Assessment (Class EA) process.

Your letter indicates that the project is a schedule B project. In accordance with the Municipal Class EA, Schedule B projects require that a Project File be prepared. The Project File shall be organized in such a way as to clearly demonstrate that the appropriate steps in Phases 1 and 2 have been followed and explain the following:

- background to the project and earlier studies;
- the nature and extent of the problem or opportunity, to explain the source of the concern or issue;
- description/inventory of the environment;
- the alternative solutions considered and the evaluation process followed to select the preferred solution:
- · follow-up commitments, including any monitoring necessary; and
- the public consultation program employed and how concerns raised have been addressed.

ABORIGINAL CONSULTATION INFORMATION

Consultation with Interested Persons under the Ontario Environmental Assessment Act

Proponents subject to the Ontario *Environmental Assessment Act* are required to consult with interested persons, which may include First Nations and Métis communities. In some cases, special efforts may be required to ensure that Aboriginal communities are made aware of the project and are afforded opportunities to provide comments. Direction about how to consult with interested persons/communities is provided in the Code of Practice: Consultation in Ontario's Environmental Assessment Process available on the Ministry's website:

You are advised to provide notification directly to all of the First Nation and Métis communities who may be interested in the project. You should contact First Nation communities through their Chief and Band Council, and Metis communities through their elected leadership.

Rights-based consultation with First Nation and Métis Communities

Proponents should note that, in addition to requiring interest-based consultation as described above, certain projects may have the potential to adversely affect the ability of First Nation or Métis communities to exercise their established or credibly asserted Aboriginal or treaty rights. In such cases, Ontario may have a duty to consult those Aboriginal communities.

Activities which may restrict or reduce access to unoccupied Crown lands, or which could result in a potential adverse impact to land or water resources in which harvesting rights are exercised, may have the potential to impact Aboriginal or treaty rights. For assistance in determining whether your proposed project could affect these rights, please refer to the attached "Preliminary Assessment Checklist: First Nation and Métis Community Interest."

If there is likely to be an adverse impact to Aboriginal or treaty rights, accommodation may be required to avoid or minimize the adverse impacts. Accommodation is an outcome of consultation and includes any mechanism used to avoid or minimize adverse impacts to Aboriginal or treaty rights and traditional uses. Solutions could include mitigation such as

adjustments in the timing or geographic location of the proposed activity. Accommodation may in certain circumstances involve the provision of financial compensation, but does not necessarily require it.

Delegation of Procedural Aspects of Consultation

Proponents have an important and direct role in the consultation process, including a responsibility to conduct adequate consultation with First Nation and Métis communities as part of the environmental assessment process. This is laid out in existing environmental assessment codes of practice and guides that can be accessed from the Ministry's environmental assessment website at:

www.ontario.ca/environmentalassessments

The Ministry relies on consultation conducted by proponents when it assesses the Crown's obligations and directs proponents during the regulatory process. Where the Crown's duty to consult is triggered, various additional procedural steps may also be asked of proponents as part of their delegated duty to consult responsibilities. In some situations, the Crown may also become involved in consultation activities.

Ontario will have an oversight role as the consultation process unfolds but will be relying on the steps undertaken and information you obtain to ensure adequate consultation has taken place. To ensure that First Nation and Métis communities have the ability to assess a project's potential to adversely affect their Aboriginal or treaty rights, Ontario requires proponents to undertake certain procedural aspects of consultation.

The proponent's responsibilities for procedural aspects of consultation include:

• Providing notice to the elected leadership of the First Nation and/or Métis communities (e.g., First Nation Chief) as early as possible regarding the project;

- Providing First Nation and/or Métis communities with information about the proposed project including anticipated impacts, information on timelines and your environmental assessment process;
- Following up with First Nation and/or Métis communities to ensure they received project information and that they are aware of the opportunity to express comments and concerns about the project. If you are unable to make the appropriate contacts (e.g. are unable to contact the Chief) please contact the Environmental Assessment and Planning Coordinator at the Ministry's appropriate regional office for further direction.
- Providing First Nation and/or Métis communities with opportunities to meet with appropriate proponent representatives to discuss the project;
- Gathering information about how the project may adversely impact the relevant Aboriginal and/or Treaty rights (for example, hunting, fishing) or sites of cultural significance (for example, burial grounds, archaeological sites);
- Considering the comments and concerns provided by First Nation and/or Métis communities and providing responses;
- Where appropriate, discussing potential mitigation strategies with First Nation and/or Métis communities;
- Bearing the reasonable costs associated with these procedural aspects of consultation, which may include providing support to help build communities' capacity to participate in consultation about the proposed project.
- Maintaining a Consultation Record to show evidence that you, the proponent, completed all the steps itemized above or at a minimum made meaningful attempts to do so.
- Upon request, providing copies of the Consultation Record to the Ministry. The Consultation Record should:
 - summarize the nature of any comments and questions received from First Nation and/or Métis communities;
 - o describe your response to those comments and how their concerns were considered:
 - o include a communications log indicating the dates and times of all communications; and
 - document activities in relation to consultation.

Successful consultation depends, in part, on early engagement by proponents with First Nation and Métis communities. Information shared with communities must be clear, accurate and complete, and in plain language where possible. The consultation process must maintain sufficient flexibility to respond to new information, and we trust you will make all reasonable efforts to build positive relationships with all First Nation and Métis communities contacted.

If you need more specific guidance on Aboriginal consultation steps in relation to your proposed project, or if you feel consultation has reached an impasse, please contact the Environmental Assessment and Planning Coordinator at the Ministry's appropriate regional office.

Preliminary Assessment Checklist: First Nation and Métis Community Interests and Rights

In addition to other interests, some main concerns of First Nation and Métis communities may pertain to established or asserted rights to hunt, gather, trap, and fish – these activities generally occur on Crown land or water bodies. As such, projects related to Crown land or water bodies, or changes to how lands and water are accessed, may be of concern to Aboriginal communities.

Please answer the following questions and keep related notes as part of your consultation record. "Yes" responses will indicate a potential adverse impact on Aboriginal or treaty rights.

Where you have identified that your project may trigger rights-based consultation through the following questions, you should arrange for a meeting between you and the Environmental Assessment and Planning Coordinator at the Ministry's appropriate regional office to provide an early opportunity to confirm whether Ontario's duty to consult is triggered and to discuss roles and responsibilities in that event.

The Project File must contain a complete record of all activities associated with the planning of the Project and shall include:

- correspondence;
- copies of notices, letters, bulletins relating to public consultation;
- memoranda to file explaining the proponent's rationale in developing stages of the project;

- copies of reports prepared by consultants and others.

The project documentation must be maintained in such a way that it is suitable for easy review by the public at any time.

Once the Project File is finalized a Notice of Completion is required to be issued, allowing the public at least a 30 calendar day period during which documentation may be reviewed and comment and input submitted to the Municipality. The Notice of Completion shall advise the public of their rights to contact the Minister of the Environment and request a Part II Order.

Consultation with First Nation and Métis Communities

Your proposed project may have the potential to affect Aboriginal communities who hold or claim Aboriginal or treaty rights protected under Section 35 of Canada's *Constitution Act* 1982. The Crown has a duty to consult First Nation and Métis communities when it knows about established or credibly asserted Aboriginal or treaty rights, and contemplates decisions or actions that may adversely affect them.

Although the Crown remains responsible for ensuring the adequacy of consultation with potentially affected Aboriginal communities, it may delegate procedural aspects of the consultation process to project proponents.

The environmental assessment process requires proponents to consult with interested persons and government agencies, including those potentially affected by the proposed project. This includes a responsibility to conduct adequate consultation with First Nation and Métis communities.

The Ministry relies on consultation conducted by proponents when it assesses the Crown's obligations and directs proponents during the regulatory process.

Where the Crown's duty to consult is triggered in relation to your proposed project, the Ontario Ministry of the Environment is delegating the procedural aspects of rights-based consultation to you through this letter.

Steps that you may need to take in relation to Aboriginal consultation for your proposed project are outlined in the attached "Aboriginal Consultation Information" document. Please complete the checklist contained there, and keep related notes as part of your consultation record. Doing so will help you assess your project's potential adverse effects on Aboriginal or treaty rights.

You must contact the Director, Environmental Approvals Branch if you have reason to believe that your proposed project may **adversely affect an Aboriginal or treaty right**, **consultation has reached an impasse**, or if an elevation request is anticipated. The Ministry will then assess the extent of any Crown duty to consult in the circumstances, and will consider whether additional steps should be taken and what role you will be asked to play in them.
