

# **The Township of Cavan Monaghan**

## **By-law No. 2014-06**

### **Being a by-law to regulate the disposal of refuse, debris and snow within the Township of Cavan Monaghan**

**Whereas** the Municipal Act, S.O. 2001, c.25, s.127 as amended, permits municipalities to pass by-laws prohibiting the throwing, placing, or depositing of refuse or debris on property of the municipality;

**And Whereas** it is desirable to prohibit the throwing, placing or depositing of refuse or debris in any place in the Township other than the Township of Cavan Monaghan Transfer Station;

**And Whereas** it is desirable to prohibit the throwing, placing or depositing of snow on roadways and other public thoroughfares in the Township.

**Now Therefore** the Council of the Township of Cavan Monaghan enacts as follows:

#### **1.0 Definitions and Interpretation**

- 1.1 This By-law may be cited as the Disposal of Refuse, Debris and Snow By-law.
- 1.2 In this By-law, refuse and debris shall have the meanings normally ascribed to them and, without limiting the generality of the foregoing, shall include:
  - 1.2.1 The portions and containers of food unused or discarded in the preparation, serving and consuming thereof.
  - 1.2.2 All discarded material arising or resulting from the operation of households, business establishments and public places; and
  - 1.2.3 Brush, stones, surplus concrete, broken concrete or asphalt.

#### **2.0 General Duties and Obligations to Comply**

- 2.1 No person shall spill, scatter, deposit, throw, cast, lay or cause to be thrown any refuse or debris on any street, lane, alley, laneway, roadway, road allowance, public or private way, or in any public square or place.
- 2.2 No person shall shovel, plow, deposit, throw, cast, lay or cause to be thrown any snow on any street, lane, alley, laneway, roadway, road allowance, public way, or in any public square or place.

**2.3** Materials applied to land for agricultural purposes are exempt from the provisions of section 2.1 of this By-law.

**3.0 Administration and Effective Date:**

**3.1** The Municipal By-law Enforcement Officer appointed by the Township of Cavan Monaghan or a Police Officer shall enforce this By-law.

**3.2** Any person who contravenes any of the provisions of this By-law is guilty of an offence and upon conviction is liable to a fine or penalty as stated in Schedule A to this By-law, exclusive of the costs, as prescribed by the Provincial Offences Act, R.S.O. 1990, cP.33, as amended.

All previous by-laws to regulate the throwing, placing or depositing of refuse, debris or garbage are repealed in their entirety.
