



Wastewater Treatment Plant Upgrades **Notice of Completion**

Class Environmental Assessment

The Township of Cavan Monaghan has completed the Municipal Class Environmental Assessment Study to address renewal, capacity and environmental performance issues associated with the Millbrook Wastewater Treatment Plant.

The preferred alternative is to expand and upgrade the existing Millbrook WWTP on the existing site and adjacent property to include an activated sludge process for secondary treatment and tertiary filtration for tertiary treatment. This alternative will improve effluent quality, increase capacity to accommodate future flows and upgrade/replace aged equipment and infrastructure. Due to available funding support through the Build Canada Fund, the preferred alternative is financially feasible and economically advantageous compared to other alternatives. Investigations and evaluations determined the preferred alternative to provide improved water quality of the water into Baxter Creek and to have the least negative environmental and social impacts. Detailed design of the wastewater treatment plant upgrade and expansion will be finalized in the next phase.

The Township has completed this study in accordance with **Schedule "C"** of the **Municipal Class Environmental Assessment** October 2000, as amended in 2011. A Class EA report has been prepared to document the planning and decision-making processes followed. Notices of the Study of Commencement and the Public Information Meetings were distributed to the public, interested parties and regulatory agencies.

By this Notice, the report is being placed on public record for a 30-day review period in accordance with the requirements of the Municipal Class EA. Subject to comments received as a result of this Notice and receipt of necessary approvals, the Township intends to proceed with the detailed design and construction of this project. The Class EA report is available for review at the following locations starting Monday, April 22, 2013.
