Notice of Public Meeting Minor Variance Application MV-06-24

Take Notice that the Council of the Township of Cavan Monaghan will hold a public meeting of the Committee of Adjustment to consider a proposed minor variance under Section 45 of the Planning Act, R.S.O. 1990, as amended.

Date and Time: Thursday, July 4th, 2024 at 9:00 a.m.

Location of 923 Highway 7A (Cavan)

Subject Lands: Township of Cavan Monaghan

Property Roll Number: 1509-010-003-23700

The lands subject to the minor variance application are

shown on the Key Map on Page 3.

Purpose of the Proposed Minor Variance:

A minor variance is required to permit the establishment of a 32.4 square metre (348.8 square foot) shipping container on the property as an addition to the existing building. The shipping container will be within the rear yard setback.

A motor vehicle gas bar and retail store are located on the subject property. The shipping container has been clad, enclosed and attached to the principle building for additional storage for the retail store.

The property at 923 Highway 7A is an existing lot of record approximately 0.33 hectares (0.81 acres) in size with 35 metres (115 feet) of frontage on Highway 7A.

The property is zoned Hamlet Commercial (C2) as shown on Map D-2 to By-law No. 2018-58, as amended. The C2 Zone permits a motor vehicle gas bar and a retail store. A shipping container is not permitted in Commercial Zones.

The purpose of the minor variance is to:

- 1) permit the establishment of one (1) shipping container as an enclosed addition to the existing building on the subject property; and,
- 2) reduce the legal non-complying rear yard setback from 2.59 metres (8.4 feet) to 0.89 metres (2.92 feet).

All other regulations of the C2 Zone will apply to the property.

Participation

Committee of Adjustment Meetings are held electronically.

Any person may attend the electronic/virtual public meeting and make written and/or verbal submissions either in support of or in opposition to the proposed minor variance.

The Township is using Zoom for electronic meetings and it is the responsibility of the interested member of the public to have technology in place to connect to the meeting.
