Policy Statement

The Township of Cavan Monaghan is implementing a Toilet Rebate Program to reduce water use in homes within the Township; to lower the impacts on the environment; to reduce costs to the users of the water and wastewater systems; and to accommodate further allocation for growth thereby further reducing overall costs. Toilets consume the highest water volume within a home and new models are capable of using half to a third of the consumption of existing toilets.

Purpose

Residents of the Township of Cavan Monaghan are eligible for a \$100 rebate per toilet replaced that meets the requirements of this policy. The new toilet has to meet the criteria of 4.8 L/flush or a dual flush of 3 L/6 L. Many of these replacements would be from a previous 6, 8 or 12 L flush. The rebate program is available exclusively for residential units located within Township of Cavan Monaghan that are connected to both the municipal water and the municipal sanitary sewer system or on private services.

Procedure

To be eligible for the rebate offer, the Applicant must:

- Request an inspection of the existing installed toilet prior to the new installation.
- Purchase and install an eligible low flow toilet as approved by the Director of Public Works.

- Fill out the application form and submit it with a copy of the original sales receipt.

The program does not apply to new construction, or new bathroom additions; it must be a replacement toilet. The Township reserves the right to an on-site inspection of the new toilet, if required.

In consideration of receiving the rebate under the Toilet Rebate Program, the applicant acknowledges and agrees:

1. That the Township of Cavan Monaghan may deny any application that does not meet Program requirements.
2. That the installation of the number of water efficient toilets indicated in the attached Application Form has been completed. The toilet(s) must be installed prior to submission of rebate request.
3. That the Township of Cavan Monaghan does not guarantee or warranty (i) the performance of any toilet; (ii) that its installation will be free of defects; (iii) the quality of workmanship.
4. If this Application contains any material misstatement or misrepresentation, or if the Applicant breaches any of the terms or conditions contained herein, the rebate will be voided.
5. The Township of Cavan Monaghan reserves the right to alter or discontinue the program at any time. Submission of an application does not guarantee a rebate.
