## By-law No. 2024-xx

# Being a by-law to amend By-law No. 2018-58, as amended, otherwise known as "The Township of Cavan Monaghan Zoning By-law"

**Whereas** the Township of Cavan Monaghan received an application to amend Zoning By-law No. 2018-58, as amended;

And Whereas the Township of Cavan Monaghan adopted Official Plan Amendment No. x to the Township of Cavan Monaghan Official Plan to set the policy context for the proposed rezoning;

**And Whereas** the Township of Cavan Monaghan required the rezoning of the subject lands to permit the establishment of a farm resort on the property;

**And Whereas** the Council of the Township of Cavan Monaghan reviewed the proposed rezoning and now deems it advisable to further amend By-law No. 2018-58, as amended.

**Now Therefore** the Council of the Township of Cavan Monaghan hereby enacts as follows:

- 1. Map G-2 of Schedule "A" to By-law No. 2018-58, as amended, is hereby amended by changing the zone category on the lands known municipally as 401 Elgar Drive and described as Part 1, RP 9R2379, Part of Lots 8 and 9, Concession 2 (Cavan) from the Oak Ridges Moraine Core (ORMC) Zone to the Oak Ridges Moraine Core Exception One (ORMC-1) Zone as shown on Schedule "1" attached hereto and forming part of the By-law.
- 2. Section 9.3 of By-law No. 2018-58, as amended, is further amended by the addition of Section 9.3.6 that shall read as follows:

#### "9.3.6 ORMC-1 Map G-2 of Schedule A (2024-xx Murad)

- a) Additional permitted use: a farm resort;
- b) A farm resort is defined as "a farming operation that provides, as a secondary use, educational and active opportunities related to farm operations that:
  - allow guests to experience and enjoy the agricultural way of life;
  - are compatible with and do not hinder the surrounding agricultural operations; and
  - occupy a limited area of the property."
- c) Overnight accommodation related to the farm resort use shall be limited to six (6) guest rooms located in the single detached dwelling existing (renovated barn) as of January 1, 2024.


- d) Recreational uses are limited to low-intensity recreational uses as defined in the Oak Ridges Moraine Conservation Plan (ORMCP).
- e) The farm resort shall clearly be secondary to the agricultural use of the property and shall not change the character of the property.
- f) The farm resort shall not create or become a public nuisance with regard to noise, traffic, emissions, parking or communication interference.
- g) The farm resort shall be operated by the resident farmer or a resident member of the farm family.
- h) The farm resort shall employ a maximum of one (1) employee in addition to the permanent residents of the single detached dwelling related to the agricultural use.
- i) The farm resort use shall be limited to 2% of the area of the farm parcel to a maximum of 1 hectare (2.5 acres).
- j) The farm resort use shall not be rented to any one party for more than fourteen (14) consecutive days.
- k) No sign or display other than a non-illuminated sign not exceeding 1 square metre in area shall indicate that a farm resort business is being operated on site.
- I) All other relevant provisions of By-law No. 2018-58, as amended, shall apply.

If no notice of objection is filed with the Clerk within the time provided, this By-law shall become effective on the date of passing.

If a notice of objection is filed with the Clerk, this By-law shall become effective on the date of passing hereof subject to the disposition of any appeals.
